Chairman's Report

We had a very positive AGM session at the end of April. Membership is increasing, now well over 400, the 20mph pilot has been confirmed as permanent, and we heard about another excellent local garden, the Lost Garden of Penicuik House from our guest speaker.

We handed out the remaining tree saplings received from Action Earth which now means that over 400 new trees have been planted locally. And our finances are stable with costs being controlled and membership resilient.

We welcomed two new members of our Committee, Cheryl Ashworth who was elected at the AGM, and George Clark who subsequently volunteered and was co-opted onto the Committee at our May meeting. A big welcome to both of them.

The biggest challenge for the future seems to be the Midlothian Local Development Plan which, we learned a few days after the AGM, is having a few small changes made to it in the light of consultation responses and will then be sent back to Scottish Ministers for approval.

We will look at the final version, and the Council's published responses to consultation points, and will monitor progress once the implementation phase arrives. Our aim will be to identify where there will be an impact on the Lasswade area. Look out for further news on this.

Most likely this will be related to transport issues on most of our roads, and we will look out for ways of extending the 20mph limit where justifiable as well as encouraging recognition of the limit by drivers and enforcement of the limit where appropriate.

Other challenges (for us at least) include the development of a more robust website and identifying the best use for our members of social media. We think that developing a library of photos of the Lasswade area, showing it in all its glory, might be a good first move.

Litter continues to be a big problem locally, and our litter-picking and scrutiny will continue to be an important part of our activity. We see a focus on the local heritage of Lasswade buildings, through obtaining oral histories from current or former local residents, as being potentially valuable in enhancing current knowledge sources about our area.

to take this opportunity to thank everyone who has taken the time to be involved.

Mavisbank House and Grounds

It has come to our attention that Mavisbank House was de-scheduled from Ancient Monument Status to Listed Status on 10th October 2016. The Ancient Monument Status was conferred on 11th January 1991. The authority to de-schedule was conferred on Historic Environment Scotland under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

The de-scheduling includes Mavisbank (New Saughton Hall) house, doocot, polices and earthworks. We are, at the time printing, unable to ascertain why the designation has been changed and what implications, if any, this will have for the future use of Mavisbank House and Grounds. The view of the Society, having canvased you our Members on two occasions, is that we would support a 'Light touch approach' in respect of any future development. We believe that Mavisbank represents valuable green space that provides an excellent public amenity.

These views are compatible with our aim to protect the status of the North Esk Valley as an Area of Great Landscape value. If you are interested in the future of Mavisbank, please contact us by e-mail dequinceyrose@aol.com or by telephone 663 6651.

Air Pollution Survey in Lasswade Village

Midlothian Council have agreed to carry out an air pollution survey on the main road through Lasswade Village. The Society negotiated with the Public Health Air Quality Department and the Survey is expected to begin in January 2017 and will continue for a period of 12 months. Passive Diffusion Tubes will be used to record the air quality. There are guidelines that will be followed for the placing of tubes. Indeed their survey processes have been reviewed by SEPA and Scottish Government and they have had their protocols audited without adverse comment.

The tubes will be changed monthly and sent to for laboratory analysis. Bias correction methods have been developed to reduce the error in results of the diffusion tube survey. The most robust of these methods is expected to be used, co-location of the tubes with a continuous monitor to calculate the bias. Results are expected within the next 18months.

Planning Matters

There are 2 current Planning Applications that have been brought to our notice by Members, should you wish to make comment on either of these Applications there are contact details below:

Erection of 9 dwelling houses, formation of new access road and car parking and associated work.
Midlothian Council Planning Dept. Ref No. 16/00733/DPP - Open for comment until 6th December 6TH December 2016

This is on the site, of the now demolished, 'Old Primary School' adjacent to the Laird and Dog Hotel. Concerns have been raised about the road access and density of housing on this site.

2. Haveral Wood – Application has been made to fell the majority of the trees. The wood lies in the valley between Loanhead and Lasswade. There is approx. 5 acres of woodland.

Concerns have been raised over the loss of amenity for both wildlife and walkers. A path runs through the wood.
