We look forward to your comments on the proposals for Mavisbank House and Grounds. Lucy Wood, who has been appointed as Engagement Officer for the Edinburgh Greenspace Trust, has very kindly agreed to give a Talk to the Society.

Members have brought to our attention a number of areas that require maintenance and repair. Unfortunately Midlothian Council have taken the decision to put all non-essential works on hold until they determine the 2019/20 Budget. We will continue to petition the Council to carry out necessary repairs. We have, for example, highlighted the poor condition of the bus-stop within the the Community Garden and noted that without maintenance, the roof and windows will rot because of water ingress. Gutters and a down pipe need to be attached to the shelter, to divert rain.

Please let us know when you spot problems with the infrastructure.

We would like to thank once again, the Society's Reps who give such dedicated service on your behalf. I wish them dry weather as they deliver your Newsletter, collect subs and find out what issues you wish the Society to take up on your behalf.

Update on the Plans for Mavisbank House and Grounds

The Landmark Trust (TLT) and Historic Environment Scotland (HES) continue to work together to explore the potential for a project at Mavisbank. Whilst no detailed proposals has been identified, the Landmark Trust's ultimate goal would be for holiday accommodation and the provision of community facilities, possibly artist's studio space, within the building.

As you may be aware the Landmark Trust https://www.landmarktrust.org.uk, specialises in restoring old historic buildings to provide holiday accommodation.

The Civic Society has polled Members twice in the past few years and almost 100% of responses supported a light-touch approach to the development of both the house and grounds.

Restoration of the house and grounds would require significant funding and the TLT mand HES, recognise that Midlothian Council cannot provide financial support. HES and TLT may apply in Autumn 2019 for a Grant from the Heritage Lottery Fund. That would need to be followed by approaches to other funding sources due to the scale of money, likely to be required for any TLT project.

A successful bid to the Heritage Lottery Fund would require to demonstrate considerable Community engagement and support for any project, as well as showing how that community would benefit from the investment. To that end Edinburgh and Lothians Greenspace Trust have received funding from from HES to undertake Community engagement in the Loanhead, Bonnyrigg and Lasswade areas, in an effort to promote the House and grounds. Lucy Wood has been appointed as the Engagement Officer, to undertake this work. Midlothian Council's Communities and Planning Teams have been tasked with assisting Lucy in her work.

All parties are aware of significant concerns raised by Midlothian Council regarding any development which increases traffic through Polton Bank, Lasswade.

It is recognised that access is one of a number of issues that would require detailed consideration before any application, could be put before the Heritage Lottery Fund.

The reasons the Lottery gave for turning down an Application in 2013, related to

- There being insufficient evidence of community engagement and involvement in the Project.
- Ownership of the property not being known and secure.
- Project not having suitable access into the grounds of the house. Consideration has been given to constructing road access from Loanhead to the House, with attendant street lighting.

As yet no such application has been considered by Midlothian Council.

- Concerns over the long-term sustainability of the project in terms of visitors and income.
- Heritage Lottery not being convinced of HES's (then Historic Scotland) full support for the Project.

Given the bio-diversity and historic value of Mavisbank House and Grounds, many Members, including Tom Delaney, who carried out a comprehensive Ornithological Survey, have expressed an interest in the future of this site. We look forward to your comments.

The closing date for the Competition is 31st March 2019. This allows you to include images of the forthcoming Winter and Spring.




