Planning and Lasswade District Civic Society

The Civic Society maintains a watching brief over planning applications which might affect the character and amenity of our community. Assessment of planning applications is a standing item on our committee meetings when such applications are discussed and a decision is made as to whether comment is required from the Society. Over the past two years I have undertaken the role of monitoring the Midlothian Council planning portal https://planning-applications.midlothian.gov.uk OnlinePlanning/ and researching potential issues. We note, in particular, if any comments from residents are submitted and take into account any 'material planning considerations'. We have looked at about 40 applications and passed comment on six.

This phrase, 'material planning considerations', is of great importance as it is only on the basis of these matters that a council can make judgements about applications. They are part of planning legislation as set out in law determined by the Scottish Parliament. Midlothian Council has a guide to make a comment on their website - https://www.midlothian. gov.uk/info/200167/planning_applications/34/search_ and comment on planning applications. The material considerations are listed on page 2 with the most important of these being compliance with the Local Development Plan and in the context of Lasswade, the effect on historic buildings and conservation areas. It is also made clear what is not material and lists some of the more common comments which cannot be considered. When making a comment it is always useful to read the developers statement on the portal and base any comments on potential flaws in their argument for approval of the development. It is also reasonable to look at individual circumstances and the potential for loss of amenity but this is not something the Society would necessarily comment on.

Lasswade History Project

Earlier this year Wendy MacMillan and I were privileged to meet Mrs Grace Costello for a coffee at the Papermill. Grace vividly recalled fascinating tales of growing up in Lasswade during the 1940s and 50s and really brought Lasswade's recent past to life. Grace brought along a copy of the book 'Old Lasswade and Bonnyrigg' by Oliver Van Helden (1997) and as we viewed the old back and white photographs on each page, she recalled details of the people who lived in the various houses depicted, the numerous shops and their proprietors in the centre of Lasswade and other features of this bygone age including a dairy farm, the old church, the carpet factory and blacksmiths.

The history page of the new LDCS website will include more fascinating snippets from oral histories provided by Grace and other former Lasswade residents. Please take a look!

We would like to thank Mrs Grace Costello and others who have generously given their time to this project.

Lasswade and District Civic Society Annual General Meeting

Our AGM will take place on Wednesday 29th April from 7.30pm at St. Leonards Church Hall. Cameron Manson will give a talk on 'The Esk - the influence of the river on the settlements through which it passes'

The actual process consists of an initial assessment by planning officials who look at relevant issues and produce a report for councillors who make the actual decision. All Midlothian councillors are members of the planning committee. Permission can be refused at this stage but developers have the ability to have this decision looked at again at the Local Review Body (LRB) who can reverse this decision. Objectors do not have access to the LRB but can make submissions. Notice of appeal to the LRB appears on the planning portal and is communicated to those who made comments on the original application. There is a further level of appeal to Planning and Environmental Appeals division of the Scottish Government, commonly known as 'the Reporter'. Their report cannot be appealed and the only way to challenge this is to apply for judicial review in the Court of Session.

Planning is an area where differences of view can lead to conflict. Planning law is an attempt to balance the interests of various parties. It has been recognised that the balance has not always been achieved in the past and a new planning law was passed last year. The planning framework arising from this is still in development. More information can be found on the Transforming Planning website https://www. transformingplanning.scot. Included in this is a framework for community engagement which includes the development of Local Place Plans. This framework is still in development and comments can still be submitted for this first stage. A guidance leaflet is available https://www.transformingplanning.scot/ media/1146/npf4-early-engagement-have-yoursay-leaflet.pdf. A members' reflections on a problem that taxes us all

Our littering problem: it's a symptom, not the disease

A short walk from my house in Lasswade takes me into the valley of the North Esk. The river path south goes into spectacular Roslin Glen, and north into the Mavisbank House estate. For me, these are oases peace and respite from Midlothian's increasingly frenetic environment. The Esk Valley is also a vital sanctuary for animals whose habitats are rapidly being entombed beneath roads and identikit suburban villas.

I despair, and sometimes rant online, about the amount of litter that people leave in these precious places. Plastic bottles float down the river, carrier bags stay tangled in branches for years, baggies of dog waste pile up beside the path or hang like ornaments in the bushes. Fast food packaging is jettisoned from cars and flattened into the tarmac. All over Scotland, people visit our beauty spots, take selfies and leave their rubbish behind. Even the plastic sheaths protecting baby trees break down and pollute our waters.

It's easy to blame a few thoughtless individuals. However, litter is a symptom of a greater disease: powerlessness. The forces that affect our lives feel too big to fight. We know about the climate emergency, but not what to do about it. We don't always like decisions our politicians make, but wonder if our votes make a difference. Even in our own lives we feel helpless. We know what we should do to be happier and healthier, but life is so stressful that those changes seem impossible. If we believe we have no power, we soon forget that our actions matter. Governments and multinationals trash the planet on an industrial scale, so who cares if I throw a crisp packet in the river?

But we do have power, and we have responsibility. Local groups such as the Lasswade and District Civic Society, where I live, do regular but often unrecognised work for the environment. They will be having a litter pick in Lasswade on 5 April, 2:30- 4pm, meeting opposite the Laird and Dog pub. Everyone is welcome.We all have the power to be the change we want to see in the world, step by tiny step.
