# **Chairman's Report**

Midlothian Council are looking for feedback as part of their consultation on whether to install a "yellow box" at the Westmill Road junction. Please let us have your thoughts.

As this is the first Newsletter of the year, I would like to take the opportunity of thanking Ian Barr for once again providing the Christmas tree for the village and also the Council for its contribution in brightening up the Community Garden with the reindeer statues and the Christmas lights.

Finally, I should draw your attention to the excellent work carried out by two of our members (socially distanced of course) over the last few weeks to tidy up the Community Garden. I'm sure you will agree from the photograph in this Newsletter that it is looking splendid, as the growing season gets under way. The stoicism of our volunteers in then waiting in the queues to dump the garden refuse at the Recycling Centre in Newtongrange was very commendable! # **Mavisbank House Vox Pop**

Historic Environment Scotland (HES) have now submitted a second-round bid for funding to The Heritage Lottery Fund. It is expected that approximately half of the organisations bidding for funding will be successful. Any awards made will cover 90% of the costs of developing and costing a plan for the re-development of the Mavisbank site. Successful bidders will be given up to two years to complete this work. It is understood that (HES) will be asking for £7 million from the Lottery Fund as a contribution towards the estimated £15-20 million they expect to spend on the project.

The Society was invited along with four other local organisations to contribute to a 3min Vox-pop that was recorded on site. We wanted to share some of your thoughts that we had drawn from the recent Mavisbank Survey we conducted. We wanted to emphasise that Members were glad that the grounds were to remain accessible to the public, that they did not want the peace and tranquility to be sacrificed to over development and that the Society were keen to contribute to the planning of the project. We shall see whether these points survived the final edit when we receive our review copy. We are grateful to Prof Cheryl Ashworth for so ably reflecting your views to camera.

#### **Photographic Competition 2020**

We were delighted that Jan Jerome, distinguished local Photographer and past Chair of the Society agreed to judge the Competition.

The winning entry taken by John Blair is on the front cover. John is a long-time Member of the Society and an experienced amateur photographer. Jan was impressed by the clarity of the image, the composition and the subject matter. Jan noted that is often difficult for Photographers to achieve the clarity of focus



found in John's entry. We have suggested that Jan might give a Zoom Masterclass open to Society Members. So that we might benefit from her knowledge.

John will receive  $\pounds 100$  for his first prize entry. Debbie Kong will receive  $\pounds 20$  for her excellent photo of a Moth and Martin Vevers  $\pounds 20$  for his sunset.

We hope to run the Competition again and look forward to your entries.

We would like to thank everyone who entered the Competition. Your photos will be added to the archive of images held on the website, depicting life in Lasswade. As well as local traffic, the site is visited by people from all over the world who have connections with the area.

Your photos also provide a record of the biodiversity and changing nature of our local landscape which forms part of the historical record of the village.

#### **Some Nature Observations**

I wonder if you have been watching and listening to the sights and sounds around you over these bleak winter months? It is time to look forward! The shortest day is a month or more behind us. The evening light is extending and the sun has been rising a little earlier each morning. Sunrise and sunset have both given us some dazzling spectacles. Do we dare to think of Spring even in the face of challenging weather? I have been aware of more birdsong recently and heard the dawn chorus this morning for the first time this year. It is an amazing, joyful sound for us on a mid January morning but, for the birds, it is full of purpose and ambition! They are beginning to stake out their territory and make their presence known to potential mates some weeks down the road.

I looked out of my window the other morning and spotted a couple of jackdaws on a chimney stack. They were obviously sharing some kind of breakfast taking it in turn to peck at whatever it was they had found to eat and all the while 'talking' to each other. The local corvids have been fairly chatty of late high up in the naked lime trees. It would be interesting to know what they were saying.

The other afternoon we were surprised to see an unknown gentleman darting about our garden with a strange flashing gadget in his hands. Out we went to investigate what was going on and as he continued watching the flashing red light with its attendant beeping, he explained that he was looking for his falcon! Apparently the raptor had caught a snake for lunch off the landfill sight and had flown off, prize in claws. The search went on under shrubs and small trees thinking that the bird would be on the ground devouring the delicious dinner. Suddenly the gadget did its job and there, atop the chimney pot, was the falcon, the telltale antenna protruding from a feather and a morsel of snake in its beak.

Winterwatch this evening informed me that mistletoe is a parasite. I probably knew that. The mistle thrush, one of which was seen in the area just today, loves the incredibly sticky white berries of the mistletoe. When its bill gets so sticky it cannot cope any longer, it wipes it from side to side on the branch and thereby deposits the seeds onto the bark. Soon the seeds germinate and the young plants nourish themselves off the tree and thereby happily multiply. Nature is amazing.

I have one more little story and this one is about the snowdrop. I've noticed that they are pushing their sword-like leaves up through the cold dark earth and, in our garden, beside them bloom the bright shiny yellow faces of the aconites. The snowdrop was exported to Kenya many years ago and given a name, the meaning of which is "strong but humble". From the small white bulb the Kenyans saw how this little plant pushed up through the soil, first its leaves and then the white and green flower head. However, after all this hard work, when the flower finally opened it then hung its pretty little head in humility! What a lovely description.

# **Mavisbank Conservation Area Character Appraisal and Management Plan**

#### Midlothian Council have set out their draft of this document on their website:

This is a substantial update on the previous document which dates from 2006. It is presented in a different form and is rather more readable document consisting of fewer sections, and with clearer setting out of the challenges, and the objectives of the management plan. It also reflects the changes in planning law that have been enacted.



The historical origins and significance are set out in a more narrative fashion in the first section of the document. This includes Mavisbank estate and

Polton House estate which both lie within the conservation area and also references the industrial heritage of the valley and its particular significance in the development of the paper-making industry.

The main challenges are rightly identified, in the draft, as being both Mavisbank House and the policies. The house itself is in poor condition as a result of the 1973 fire which took out the roof and the unclear ownership, leading to persistent neglect. Members will be aware of the current bid to gain funds from the Heritage National Lottery Fund on which depends the future direction of development.

There are also significant challenges in managing the policies, these having deteriorated significantly from the original planned landscape set out by Sir John Clerk. There is a need for sensitive restoration work to prevent loss of current amenity - this balance is acknowledged in the management plan

Vehicular access is also recognised as a barrier to increase public use. No specific solutions are identified in the management plan but Wadingburn Road is put forward as the most likely new access

point, should the ambitions of HES and the Landmark Trust come to fruition.

Overall this new plan is to be welcomed and especially the explicit statement that there is "the potential for small incremental changes to buildings and the public realm to have a cumulative negative impact on the area " - a concern that the Civic Society has often expressed in relation to Conservation Areas in Lasswade.

# **Repair of the Bus Shelter**
